Investment Review / Steve Caruso, Caruso-McLean

Steve presented an update on the investments which was also presented at the September 12th finance committee meeting; shared a snapshot of the account; have seen a strong performance with some accounts at about 20% return; S&P is up double digits; will look at rebalancing closer to the end of the year.
